All bid/ tender documents are to be submitted online only and in the designated cover(s)/envelope(s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

Tender documents duly filled and signed, Self attested copy of Registration Certificate, e payment form duly filled, Bid Capacity Certificates , Original Preliminary Agreement in stamp paper Rs.200/- and EMD exemption certificate (if any) shall be submitted online and subsequently in a separate cover physically on or before 06.03.2021 5PM. More details on EMD & Cost of Tender documents/ bid submission fee are mentioned in the Tender Notice.

The bids shall be opened online at the office of the Managing Director , Kerala State Warehousing Corporation, PB No. 1727, Kochi-16 08.03.2021 at 11.00 AM by the Executive Engineer <Competent Tender Opening Authority> in the presence of the Bidders / their representatives who opt to be present.
